INVESTIGATOR'S REPORT SUPPLEMENTAL

Defendant 1: Kilpatrick/Kwame/Malik/ BM 06/08/1970 9240 Dwight Detroit MI 48214 OPS: K 413-483-579-430.

Defendant 2: Beatty/Christine/Lynn/ BF 05/29/1970 16610 Westmoreland Detroit MI 48219 OPS: B 300-115-564-404

Through properly executed search warrants on SkyTel, I obtained text messages sent and received by the above defendants to each other and to others.

After review of these text messages I was able to determine that defendant number one Kwame Kilpatrick, sent and received several text messages with intimate or romantic content, to and from females that were not his wife or defendant number two Christine Beatty. These messages contain information which if revealed would be extremely embarrassing to the mayor.

Using the sender's user names and or email accounts associated with these intimate and or romantic text messages, I was able to locate and identify the individuals who sent and received text messages to defendant number one Kwame Kilpatrick.

Under the city charter for the City of Detroit the Mayor is authorized to settle lawsuits for the city with the approval of city council. On or about October 17th 2007, Kwame Kilpatrick, as the Mayor of the City of Detroit authorized the City of Detroit to enter into and 8.4 million dollar settlement of the whistleblower civil lawsuit. Defendant number 1, Kilpatrick, had refused to authorize the settlement of the whistleblower lawsuit until he learned that Michael Stefani, counsel for the plaintiffs had obtained the SkyTel text messages. Kilpatrick immediately authorized the settlement of the lawsuit. His motivation for the settlement was to prevent the release of the text messages that show he not only lied under oath about his sexual and or romantic relationship with Christine Beatty and others, but also with the corrupt motive of preventing the release of the information that would be embarrassing to him.

(Amendment to Count 4) Also, the defendant authorized the city with the corrupt motive to prevent release of the text messages containing other information I.E. intimate/romantic messages to females other than his wife or Christine Beatty which would be embarrassing to the Mayor

(Amendment to Count 6) In August of 2007 during the whistleblower civil lawsuit, defendant one Kwame Kilpatrick while testifying under oath, denied having a romantic or sexual relationship with defendant number two Christine Beatty and or other persons not his wife

Therefore this writer requests through oath and affirmation, that the Magistrate of the 36th District Court **amend count four and count six** of the original felony complaint signed by Magistrate Lockhart on March 24th 2008.
